GRADE 12 STUDENT PARKING REGULATIONS AND VEHICLE REGISTRATION

Students wishing to park on site at Seaquam Secondary are required to register their vehicle with the office. Each individual vehicle driven by a student must be registered. This privilege is open to Gr. 12 students only, and only to those who abide by the regulations set forth in this form and all other school rules. Student drivers who do not register their vehicle will be subject to consequences and may have their car towed at the owner's expense.

Student drivers must agree to the following regulations. **Please initial to acknowledge your understanding of each regulation, sign the acknowledgment on the back of this page, then complete the online GoogleDoc found on the school website under the 'Student Resources' tab.**

- Student drivers must have a valid BC driver's license and drive in compliance with local and provincial laws governing the use of a motor vehicle (ie. having the appropriate number of passengers). All vehicles driven by students must be registered and have valid insurance. Anyone parking on school grounds does so at their own risk.

- Students parking on Seaquam school grounds must park in the back parking lot only. No student parking at the front of the school is permitted. Students must park in a valid parking space. No parking is permitted in spaces marked "Staff" or "No Parking", or in any space other than a parking stall designated by white lines.

- Parking spaces in the back lot are on a "first come, first serve" basis. Spaces eligible for student use cannot be reserved. If there are no valid parking spaces open, the lot is full, and student drivers will need to find parking off school grounds (ie. street parking) at their own risk. Not being able to find a parking spot is not a valid reason for being late to class – students are expected to give themselves ample time to park and get to class.

- All drivers, including student drivers, are expected to demonstrate safe driving practices. The maximum speed on school grounds is 20 km/h. All drivers and passengers must wear seatbelts when a vehicle is in operation. Dangerous or reckless operation of a vehicle, which may endanger passengers, drivers and other members of the school community, is strictly prohibited.

- Student drivers must take responsibility for actions and behaviors occurring in and around their car. It is expected that students follow school rules, including not consuming alcohol or drugs, smoking or vaping, littering, disrupting the learning environment of the school with lights or excessive noise, or intentionally damaging other peoples' property or school property.
